## **ORDER**

The Commission orders that —

1. There be established a new Library and Information Services, &c. (State) Conciliation Committee for the industries and callings of —

Persons employed as librarians or information scientists, library assistants, library officers, library technicians, community information librarians, indexers, archivists, research assistants/officers, records management officers/librarians and positions of like nature;

excepting academic staff employed by universities who are within the present constitution rule of the University Academic Staff Association of N.S.W.;

and excepting persons within the present constitution rule of the New South Wales Social Welfare Workers' Union: provided that this exception shall not apply to persons who:

- (i)have post-secondary or tertiary qualifications requiring at least one year's full-time study or equivalent study in librarianship, archival management or records management (however described, but including library technician qualifications), and are employed in work requiring the qualifications; or
- (ii) are studying for a qualification referred to in (i) above and are employed in work which requires that such study is undertaken;

and excepting employees within the jurisdiction of the following Conciliation Committees —

Academic Staff (New South Wales Colleges of Advanced Education);

Clerks (State);

Colleges of Advanced Education Employees (State);

Crown Employees (Clerical);

Crown Employees (General);

Crown Employees (Metropolitan Meat Industry Board);

Crown Employees (Professional);

Crown Employees (Teachers);

Crown Employees (United Dental Hospitals of Sydney);

Fire Brigade Administrative and Miscellaneous Officers (State);

Fish Marketing Authority;

Independent Schools and Colleges (Teachers, &c.) (State);

Independent Schools and Colleges, General Non-Teaching Staff, &c. (State);

Motor Transport (Female Salaried Officers);

Municipal and Shire Council Employees;

Private Hospital Employees (State);

Private Hospital (Professional Staff);

Public Hospital Employees (State);

Public Hospitals Professional and Associated Staff (State);

The New South Wales Egg Corporation;

Totalisator Agency Board Employees (State);

University Employees, &c. (State);

Voluntary Care Association Employees (State);

Zoological Parks Board Employees.

- 2. The said committee shall consist of two representatives of employers and two representatives of employees.
- 3. The representatives of employers shall be appointed, upon nomination as prescribed, one by The Employers' Federation of New South Wales and one by the Chamber of Manufactures of New South Wales.
- 4. The representatives of employees shall be appointed, upon nomination as prescribed, by the Australian Liquor, Hospitality and Miscellaneous Workers Union, New South Wales Branch.
- 5. This order shall take effect on and from 1 September 1995.
