Application by the Electrical Trades Union of Australia, New South Wales Branch, industrial organisation of employees.

ORDER

The Commission orders that ----

1. The Electrical Contracting Industry (State) Conciliation Committee published 3 December 1993 (277 I.G. 593), be dissolved.

2. There be established a new Electrical Contracting Industry (State) Conciliation Committee.

The industries and callings for the Electrical Contracting Industry (State) Conciliation Committee encompass the provision of electrical services by electrical contractors and their employees.

An "electrical contractor" means any entity who or which contracts to provide "electrical services".

"Electrical services" includes:

- (1)the maintenance of electric power distribution lines and all associated work; and/or
- (2)the installation of electric light and power, all classes of assembly, wiring, repair and maintenance of electrical installations and appliances including, without in any way limiting the generality of the foregoing, the assembling, installing, diagnosing, servicing and rectifying of faults in any of the following:
- (3)electronic products (e.g., television receivers, video cassette recorders, audio equipment/systems, home computers, etc.) and any combination of these products, together with ancillary devices and/or equipment;

- (4)radio and television transmitting devices (including LF, HF, VHF and UHF); CB radios;
- (5)telemetry systems and ancillary equipment;

(6)multiple access television distribution systems;

(7) computers and their peripherals;

(8)microwave and associated equipment;

(9)electrically operated refrigeration and air-conditioning equipment;

(10)telephone communications devices;

(11)fibre optic transmission lines and associated equipment;

(12)public address systems;

(13) domestic satellite television receivers;

(14)maritime electronic equipment (including depth sounders, radars, etc.);

(15)security alarm systems;

(16)fire alarm systems;

(17)superconductivity systems and associated equipment;

(18)electromagnetic devices;

excepting employees of any entity who or which operates a business the primary purpose of which is the manufacture and/or vending of plant and equipment, albeit solely in respect of those parts or divisions of the business which are predominantly engaged in the manufacture and/or vending of plant and equipment or the installation, assembly, refurbishment and maintenance of that plant and equipment.

3. The said committee shall consist of two members representing employers and two members representing employees.

4. The members representing employers shall be appointed, upon nomination as prescribed, by The Electrical Contractors' Association of New South Wales.

5. The members representing employees shall be appointed, upon nomination as prescribed, by the Electrical Trades Union of Australia, New South Wales Branch.

6. The members representing employers and employees shall also have rights of nomination of deputy members to the said committee.

7. This order shall take effect on and from 7 April 1996.
