SAWMILLERS, &c. (STATE) CONCILIATION COMMITTEE

INDUSTRIAL RELATIONS COMMISSION OF NEW SOUTH WALES

Application by the Timber Trade Industrial Association, industrial organisation of employers.

(No. IRC 829 of 1996)

Before the Honourable Mr Justice Hill

24 April 1996

ORDER

The Commission orders that —

1. There be established a new Sawmillers, &c. (State) Conciliation Committee for the industries and callings of —

Wood machinists, wood turners, and other employees in sawmills and timber yards, employees of timber merchants and their agents on wharves or barges, employees engaged in loading or unloading timber in railway trucks, wood machinists and other employees (except wood turners) in the sawmill departments of furniture factories doing like work with employees in sawmills and timber yards, wood machinists, wood turners and other employees doing like work with employees in sawmills and timber yards, in coopers, joiners and builders' workshops, and in wire mattress making and shipbuilding and repairing establishments, timbergetters and box and case makers, woodworking machinists and sawyers and labourers carrying and stacking timber in the manufacture and repair of sporting goods in the State, excluding the County of Yancowinna;

excepting employees of —

State Rail Authority of New South Wales;
State Transit Authority of New South Wales;
The Commissioner for Motor Transport;
The Council of the City of Sydney;
Sydney Electricity;
The Electricity Commission of New South Wales, trading as Pacific Power;
The Broken Hill Proprietary Company Limited;
Australian Wire Industries Pty Ltd at its Newcastle Wiremill;
The Australian Gas Light Company;
The Council of the City of Newcastle;
South Maitland Railways Pty Limited;
The Electrolytic Refining and Smelting Company of Australia Limited;

Metal Manufactures Proprietary Limited;
 Australian Fertilizers Proprietary Limited;
 Austral Standard Cables Proprietary Limited at Port Kembla;
 Australian Iron and Steel Proprietary Limited, within the jurisdiction of the Iron
 and Steel Works Employees (Australian Iron & Steel Proprietary Limited) .
 Conciliation Committee and Quarries (Australian Iron and Steel Pty
 Limited) Conciliation Committee;
 Blue Circle Southern Cement Limited;

and excepting also —

Employees in or about coal mines north of Sydney, in or about coal mines in the
 South Coast district, in or about coal or shale mines west of Sydney;
 Engine drivers and firemen, greasers, trimmers, cleaners and pumpers, engaged in
 or about the driving of engines, electrical crane, winch and motor drivers;
 Carters, grooms, stablemen, yardmen, and drivers of motor and other power-
 propelled vehicles;
 Watchmen;
 Those engaged in the coachmaking industry and waggon and carriage making and
 repairing, and makers and repairers of agricultural and pastoral implements and
 machinery;

and excepting also employees within the jurisdiction of the following Conciliation Committees —

Clerks (State);
 Special Steels and Steel Products Manufacture (Commonwealth Steel Company
 Limited);
 Watchmen and Gatekeepers (Waterfront);
 County Councils (Electricity Undertakings) Employees;
 John Lysaght (Australia) Limited Port Kembla;
 John Lysaght (Australia) Limited Unanderra;
 Smelting and Fertilizer Manufacturing (Sulphide Corporation Pty Limited and
 Greenleaf Fertilizers Limited);
 Cement Workers, &c. (State);
 Crown Employees (Skilled Tradesmen);
 University Building Maintenance Employees (State).

2. The said committee shall consist of two representatives of employers and two
 representatives of employees, with a Conciliation Commissioner as Chairperson.

3. The representatives of employers shall be appointed, upon nomination as prescribed, one by
 the Timber Trade Industrial Association and one jointly by the Chamber of Manufactures of New
 South Wales (Industrial) and The Employers' Federation of New South Wales.

4. The representatives of employees shall be appointed, upon nomination as prescribed, by the Australian Timber Workers' Union, New South Wales Branch.
5. This order shall take effect on and from 24 April 1996.
