1. TITLE OF AGREEMENT

This Agreement shall be known as the A E Baker [Warehouse] Enterprise Agreement - 1998.

3. INCIDENCE AND PARTIES BOUND

This Enterprise Agreement is made pursuant to Chapter 2, Part 2, Division 1 of the N S W Industrial Relations Act, 1996, entered into on the 14 October, 1998 between J Blackwood and Son Limited, trading as A E Baker & Co and located at 3-9 Forge Street, Blacktown, 2148 and the employees classified as storepersons, front counter and telephone sales persons engaged to work in both the sales office and the warehouse departments.



4. TERM OF AGREEMENT

This Agreement shall have a nominal term of 12 months from 1 October 1998.

5. RELATIONSHIP TO PARENT AWARD AND AGREEMENT

It has been determined by the parties to this Enterprise Agreement that the agreement shall:

- [i] Be read and interpreted wholly in conjunction with the Storemen & Packers, General [State] Award; and
- [ii] Also be read and interpreted in conjunction with the currently registered Enterprise Agreement, approved on 19 August 1997 [Matter No. IRC 6645 of 1997], and

provided that where there is any inconsistency, this Enterprise Agreement shall take precedence.

6. DURESS

This Enterprise Agreement has not been entered into under duress by any of the parties.

7. PURPOSE OF AGREEMENT

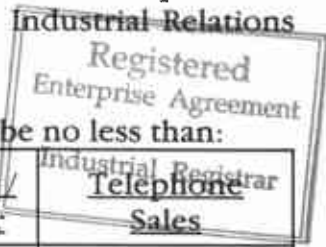
The purpose of this Agreement is to continue to pursue the aims of and to be identical to those as stated in the A E Baker Enterprise Agreement No.1 [Registered No. EA96/95] and the A E Baker [Warehouse] Enterprise Agreement - 1997 [IRC 4313 of 1997] and the A E Baker [Warehouse] Enterprise Agreement - 1997.

8. WAGE ADJUSTMENTS AND RATES

All storepersons, front counter and telephone sales employees will be granted a wage increase of 3½% from 2 October 1998, subject to overall acceptance of the company pay offer and prior to registration by the Industrial Relations Commission of NSW.

Company pay rates for adults [over 21 years of age] will be no less than:

On commencement	\$526.93	\$537.67	\$552.35
After 1 years service	\$534.20	\$544.84	\$565.21

After 3 years service	\$548.21	\$559.50	\$590.29



9. NO EXTRA CLAIMS

The parties to this agreement acknowledge that there shall be no further claims for wage increases or any further claims during the nominal term of this agreement.

10. OPERATIVE DATE

Employees party to this agreement at the time of signing acceptance will be paid the appropriate wage adjustment from the 2 October 1998 in accordance with the terms of clause 8 herein.

The employer undertakes to arrange further enterprise agreement discussions with staff party to this agreement on or before 1 October 1999.
